DESCRIPTION OF REQUIREMENTS

1. The United Nations Peacekeeping Force in Cyprus (UNFICYP), Nicosia, (Cyprus) intends to conduct a competitive solicitation exercise for the provision of maintenance and repair, including service parts for UNFICYP's diesel generators on an "as and when required" basis.

2. The Contractor shall be able to respond within seventy two (72) hours upon normal request and within twenty four (24) hours in an emergency call-out including the ability to attend island wide, where generator is located.
