1. The United Nations Peacekeeping Force in Cyprus (UNFICYP) intends to conduct a competitive solicitation exercise for the provision of rental of right-hand drive environmental friendly vehicles to UNFICYP on "as and when required" basis for an estimated initial period of two years with the UNFICYP's sole option to extend the term of the contract for an additional fourteen months period.
2. The resultant Contract shall cover the rental of two (2) Light Size Electric Sedan and two (2) Light Size Hybrid Sedan, all in white colour. UNFICYP shall have no obligation to rent any minimum number or for any minimum rental period for any vehicles covered under the Contract. The UNFICYP may occasionally rent additional vehicles on a daily or on short-term basis, above and beyond the listed quantities.
3. The Contractor must be in possession of a valid operator's license for the rental of vehicles, must be capable of providing equivalent replacement vehicles during the repair/accident repair/ maintenance period or if the vehicles are defective and shall provide servicing to the vehicles using a suitable service/repair facility in Cyprus. The Contractor shall be able to provide insurance coverage for all vehicles.
4. In this regard, UNFICYP would like to identify vendors that would be interested to participate in the competitive solicitation exercise. Qualified vendors are requested to express their interest by providing all relevant information using the attached Vendor Response Form, also available in our website [www.unficyp.org](http://www.unficyp.org). In order to be eligible for UN registration, you must declare that:

- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
