### **DESCRIPTION OF REQUIREMENTS**

- 1. The United Nations Peacekeeping Force in Cyprus (UNFICYP) intends to conduct a competitive solicitation exercise for the provision of electronic and electrical equipment repair services for an initial period of three years with the UNFICYP's sole option to extend the term of the contract for an additional two (2) periods of one year each (3+1+1).
- 2. There are approximately 300 personnel accessing UNPA on a daily basis and a percentage of which may choose to use the requested services. However, UNFICYP does not guarantee that any minimum number of personnel, visitors and contractors who have daily access to the premises will utilize the requested services.
- 3. The successful Contractor which can be an Individual or a Company, shall provide all equipment, materials and personnel at its own cost and expense. UNFICYP shall provide a space within the United Nations Protected Area (UNPA), Old Nicosia Airport, Cyprus for the service facility, on an "as is" basis. The minimum service hours required are Monday to Friday 09:00 to 16:00 hours, with optional working hours on Saturdays and Sundays. It should be noted that, all payments shall be settled directly by the recipient of the services. UNFICYP shall not be responsible for the settlement of any costs related to this Contract.
- 4. In this regard, UNFICYP would like to identify individuals or companies that would be interested to participate in the competitive solicitation exercise. ### 1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (<a href="www.ungm.org">www.ungm.org</a>) with the UN Secretariat in order to be eligible to participate in any solicitation. ### **Prerequisites for Eligibility**

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:

  - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary of affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15.
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.
