DESCRIPTION OF REQUIREMENTS

1. The United Nations Peacekeeping Force in Cyprus (UNFICYP) intends to conduct a competitive solicitation exercise for the provision of bus (15, 25 and 55 passenger seating capacity) transportation services for the facilitation of bi-communal meetings and excursions on "as and when" required basis. All routes shall be initiated from the southern part of the island and shall be transporting passengers, islandwide (covering northern and southern part of the island).

2. The requirement is on "as and when required" basis. The resulting contract will be for an initial period of three (3) years with the UNFICYP's sole option to extend the term of the contract for an additional two (2) periods of one (1) year each (3+1+1).

3. In this regard, UNFICYP would like to identify vendors that would be interested to participate in the competitive solicitation exercise. Qualified vendors are requested to express their interest by providing all relevant information using the attached Vendor Response Form, also available on our website www.unficyp.org.
