#### **DESCRIPTION OF REQUIREMENTS**

1. The United Nations Peacekeeping Force in Cyprus (UNFICYP) intends to conduct a competitive solicitation exercise for the supply and delivery of industrial and domestic kitchen equipment to UNFICYP. Depending on the outcome of the exercise, UNFICYP may award one or multiple purchase orders as deem appropriate.

Where applicable, items shall be operating with power supply of 230V/50Hz and fitted with 3 pin fused plug. All items shall be delivered on the basis of Delivered at Place (DAP) - UNFICYP HQ, Nicosia, Cyprus (Incoterms 2010). Partial deliveries are not acceptable by UNFICYP.

- 2. A minimum of one (1) year warranty unless otherwise indicated, together with service support for parts and labour shall be required. All EOI respondents shall confirm if they can support after sales service during the warranty period.
- 3. In this regard, UNFICYP would like to identify vendors that would be interested to participate in the competitive solicitation exercise. Qualified vendors are requested to express their interest by providing all relevant information including complete company details and experience profile using the attached Vendor Response Form, also available in our website www.unficyp.org.
